

MINUTES OF THE

**CALL TO ORDER:** Supervisor Tom Rowe called the meeting to order at 6:08PM.

**ROLL CALL** was taken during the Road District Budget Hearing and, Present were: Supervisor Tom Rowe, Clerk Phil Silagi, Trustees Lee Drendel, Laurene Geary, and Scott Hester, Trustee Mike Fagel was absent – deployed, and Commissioner Greg Huggins.

**BUDGET & APPROPRIATION ORDINANCE SUGAR GROVE TOWNSHIP ORDINANCE No. 2017-2:** Supervisor Rowe opened the hearing by stating that the budget as presented is unchanged from what was discussed at the April Regular Meeting which is \$289,592 budgeted for the Township, \$244,629 for the Assessor's Office, and \$625 for Payroll Service Fees for a General Town Fund total of \$534,846. The budget for General Assistance is \$12,283, and Mental Health \$111,262, which reflects total Township Appropriations of \$658,391. There was no public comment or additional Board discussion.

**ADJOURNMENT:** Supervisor Rowe asked for a motion to close the Township Budget Public Hearing. Trustee Geary motioned, and Trustee Hester seconded a motion to close the Public Hearing. Trustees Drendel, Geary, and Hester, and Supervisor Rowe voted aye. 0 nays. The Public Hearing was closed at 6:10PM.

**BUDGET & APPROPRIATION ORDINANCE #2017-1 FOR THE SUGAR GROVE TOWNSHIP ROAD DISTRICT:** Supervisor Rowe asked for comments regarding Ordinance #2017-1 appropriating for all road purposes of Sugar Grove Township Road District, Kane County, Illinois, for the fiscal year beginning April 1, 2017 and ending March 31, 2018. The Ordinance reflects appropriations of \$68,082 in the General Road Fund, \$758,010 in the Permanent Road Fund, \$130,000 in Motor Fuel Tax, and Payroll Service Fee \$250 with total appropriations of \$956,342. After discussion Supervisor Rowe asked for a motion to approve Budget & Appropriation Ordinance #2017-1 for the Sugar Grove Township Road District which was made by Trustee Geary and seconded by Trustee Drendel. Trustees Drendel, Geary, and Hester and Supervisor Rowe voted aye. 0 nays. Motion carried

**CLOSE PUBLIC HEARING:** Trustee Geary motioned, seconded by Trustee Hester to close the Public Hearing. Trustees Drendel, Geary, and Hester, and Supervisor Rowe voted aye. 0 nays. The public hearing closed at 6:08PM.
