- BUDGET & APPROPRIATION ORDINANCE #2013-2 FOR THE SUGAR GROVE TOWNSHIP: Supervisor Rowe asked for comments regarding Ordinance #2013-2 appropriating for all town purposes for Sugar Grove Township, Kane County, Illinois, for the fiscal year beginning April 1, 2013 and ending March 31, 2014. Assessor Ross informed the Board that she would be able to work within the revised budget amounts. The Ordinance reflects total appropriations of \$286,139 in the General Town Fund, \$17,000 in the Contingencies Fund, \$249,032 in the Assessor's Office Fund, \$24,200 in the General Assistance Fund, \$102,938 in the Mental Health Fund, and \$171,000 in the Community Building Fund. After no further comments, Supervisor Rowe asked for a motion to adopt Budget & Appropriation Ordinance #2013-2 for the Sugar Grove Township as presented. Trustee Hester moved, Trustee Drendel seconded, and the Board unanimously approved Budget & Appropriation Ordinance #2013-2. Trustees Hester, Drendel, Geary, and Supervisor Rowe voted aye. 0 nay. Motion carried.

The Ordinance reflects appropriations of \$446,826 in the General Road Fund and \$830,000 in the Permanent Road Fund with total appropriations of \$1,276,826.
